

Aims

There are many changes afoot in academic publishing. We therefore warmly welcome you to this day of short talks, panel discussions, and conversation aiming to optimize our collective approach to open access publishing.

Topics for discussion include new open access platforms, the peer review process and role of reviewer, use of metrics, what we can gain from IT, managing sensitive data, and the balance between sharing scientific work whilst retaining ownership.

The aims are to help optimise the accessibility and impact of scientific output, to facilitate discussions between academia and publishers, to identify where to go for help with publishing, and to address some of the common frustrations, pitfalls and challenges of publication. This will be contextualised within the University's publishing requirements.

In encouraging and facilitating open discussion between funders, academia and publishers we hope to improve channels of communication, facilitate new collaborations and strengthen working relationships.

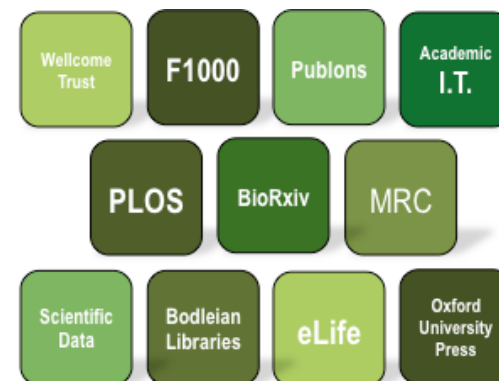

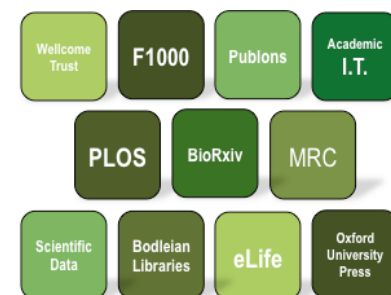


Program
